 - 3) it will be allowed to participate only Italian pilots in possession of dell'Attestato con Abilitazione al Pilotaggio Radio Comandato issued by Aero Club d'Italia valid (for foreigners' equivalent title valid in the origin country);
 - 4) any type of RC model is allowed as long as it reproduces or semi-production of a helicopter, with electric propulsion, petrol engine or turbine;
 - 5) participants shall send a registration form preferably by 15 July 2022, by sending the attached form to paola@fiamaero.it or to info@vario-elicotteri.it;
 - 6) the flights must be booked at the Exhibition Management that will guarantee the sequence of flight displays;
 - 7) participation to the event is free, a contribute quote of € 20.00 entitles the discounts package:
 - Discounted rates agreed at the restaurant
 - Possibility for guests with campers to use the reserved parking area and services of the structure, including swimming pool, provided they use the restaurant for meals.
